Administration, Staffing and Personnel

KIRC Staff Status Update: The KIRC Administrative Specialist III position has been filled by Ms. Janeece Beauchamp.

The UXO Safety Specialist position is also currently vacant. UXO safety support is currently being filled by Zapata Base Camp Management staff. We are currently reviewing the position description and responsibilities and delay making any recommendations for staffing changes.

Ms. Jennifer VanderVeur has departed the KIRC and the KIRC Ocean Specialist II position is currently vacant. We have initiated recruitment and are in the process of interviewing potential candidates to fill the position.

Ms. Kelly McHugh has departed the KIRC and the KIRC Public Information Specialist position is currently vacant. We have initiated recruitment and are currently reviewing applications.

The passage of House Bill 2594 created a new 1.0 FTE position for a KIRC Cultural Resource Project Coordinator. We are planning to initiate recruitment upon Governor's signature of the bill.

Capital Improvement, Reserve Operations and Logistics

Base Camp PV System update: Dawson mobilized to Kaho'olawe on March 13 and began a series of five, two-week access trips to Honokanai'a Base Camp. Equipment and supplies were transported to Honokanai'a via ocean vessel and then lifted from the ship's anchorage to Base Camp via helicopter; 124 bundles were airlifted. As of the end of May 2018, the contractor has completed the outdoor dining area, remodeled the dining room and refurbished the kitchen. The solar panels have been installed and the wiring leading to the generator shed has also been installed. Additionally, the new reverse omissive unit has been installed and is currently in operation. The contractor should be completing the project in June by installing the two lithium batteries and the new back-up generator.

Native Dryland Forest CIP Update: The funds for this project were released by the Governor and a solicitation for contractors was conducted by DLNR Engineering Division. Zapata Inc. was awarded the contract and has been given a notice to proceed effective May 16, 2018. The project will commence with the June 2018 KIRC access and features a dedicated contractor workforce that will mobilize to Kaho‘olawe with the Zapata Base Camp staff and be dedicated to building and supporting a dryland restoration effort in the headlands above Kāneloa Gulch on the southern slopes of Pu‘u O Moa‘ula Nui. This summer’s efforts will focus on providing water to the new project area by reroofing the water catchment and installing irrigation lines to the new planting area. This contract also features on-island support for volunteers and KIRC staff while working on this project.

Government Relations

Fiscal Audit Update: On March 8, 2018, the State Auditor requested a progress update on the status of the audit recommendations that were made in their 2013 audit report. The audit made two recommendations. The first was that the KIRC should more precisely define its vision for rehabilitating Kaho‘olawe. We reported that the KIRC has partially implemented this recommendation (see the attached report). The second was the KIRC should align its fundraising and spending plans which have been implemented and completed.

This letter is provided as the Kaho'olawe Island Reserve Commission's (KIRC) update on the recommendations made in the Auditor's Report No. 16-03, which was a follow up to your earlier Report No. 13-06.

In your Report No. 16-03, your office noted the following recommendations as "Open"

The Kaho'olawe Island Reserve Commission should:

1. More precisely define what its vision for a rehabilitated Kaho'olawe entails, including funding requirements and timelines. Specifically, KIRC should create a comprehensive and measurable restoration plan for the island that includes areas to be restored, scope of work, estimated costs and timeframes for completion; and
2. Align its fundraising and spending plans to accommodate that restoration plan. The commission should increase its fundraising and/or decrease its spending if it intends to preserve the trust.

Status of Implementation of Audit Recommendation
Report No. 16-03

Recommendation No. 1

The Kaho‘olawe Island Reserve Commission should more precisely define what its vision for a rehabilitated Kaho‘olawe entails, including funding requirements and timelines. Specifically, KIRC should create a comprehensive and measurable restoration plan for the island that includes areas to be restored, scope of work, estimated costs and timeframes for completion.

The KIRC is still working on refining its restoration vision for Kaho‘olawe. With the funding provided by Act 49 (SLH2017) and the establishment of the KIRC positions within the administration’s budget, we are now able to move forward with a more extensive planning effort.

KIRC’s restoration estimate is based upon its previous land use plan and restoration management plan “Palapala Ho‘onohono Moku‘Āina o Kaho‘olawe, Kaho‘olawe Use Plan” and “Ho‘ōla Hou i Ke Kino o Kanaloa, Kaho‘olawe Environmental Restoration Plan” and the Kaho‘olawe Strategic Community Plan, “I OLA KANALOA!” These documents provided the framework for the restoration effort but lacks specific details on how to accomplish this goal. The KIRC proposes the following plan of action to develop more precisely defined vision for the rehabilitation of Kaho‘olawe including funding requirements and timelines:

1. Develop an end-state restoration vision for each ‘ili on Kaho‘olawe (Estimated completion June 2019). The island of Kaho‘olawe is subdivided into nine ‘ili (a traditional land subdivision of an ahupua‘a). For each ‘ili a specific proposed restoration effort will be described based upon its planned use in accordance with the Kaho‘olawe Use Plan and restoration requirements necessary for the end use in accordance with the Kaho‘olawe environmental Restoration Plan. For some ‘ili, separate mauka and makai visions might be necessary due to the change in climate and terrestrial conditions within the ‘ili.
2. Generate cost estimates for each ‘ili on Kaho‘olawe (Estimated completion June 2020). Gathering current cost data for restoration efforts previously accomplished on Kaho‘olawe and extrapolating those data points that most closely fits the type of restoration envisioned in item 1 above and factoring in accessibility and infrastructure in each ‘ili, an estimate to accomplish the vision for each ‘ili will be developed.
3. Generate an overall plan of action by time-phasing the individual ‘ili restoration plans (Estimated completion June 2021). The various ‘ili restoration plans with cost estimates will be prioritized and then sequenced for accomplishment. Utilizing project management tools established by the Project Management Institute (PMI), a PERT or Program Evaluation and Review Technique Chart can be developed and analyzed for optimization and provide a guideline for future activities.

In December 2016, the KIRC approved the “Kaho‘olawe Island Reserve Commission Financial Self-Sufficiency and Sustainability Plan” (See attached memo:” To approve and accept the proposed KIRC Financial Self-Sufficiency and Sustainability Plan and attached copy of plan). The KIRC Self-Sufficiency and Sustainability Plan focuses primarily on methods of generating funding for KIRC operations and estimated operational cost for the future. This plan considers seeking funds from the administration and legislature as one of its means of fundraising. This plan was then submitted to the State Legislature as Department Communication (DC) 122 (SLH2017) (see attached cover letter :).

In the KIRC Financial Self-Sufficiency and Sustainability Plan, the three critical factors for KIRC’s financial success are:

1. Build the KIRC’s Kaho‘olawe Education & Operations Center at Kīhei, Maui as the key infrastructure/facility to generate sustaining funding for the Island’s long-term restoration and establishing a permanent, public gateway to Kaho‘olawe.
2. Establish a dedicated State funding requirement to secure a permanent workforce to restore and actively manage the Kaho‘olawe Island Reserve.
3. Create a diversified income generating portfolio to achieve financial stability.

Based upon the case study presented in the plan and the global acceptance of the plan by the Administration and Legislature, the KIRC’s request for personnel and partial operating funding was established in the Administration’s Budget request and approved as Act 49 SLH2017 for 15.00 positions and \$1,065,147 for fiscal year 2017-2018 and \$1,097,047 for fiscal year 2018-2019 in general funds for personnel and operating cost for management and restoration of Kaho‘olawe Island Reserve, thereby completing item 2 above.

Previously, Act 240 (SLH2015) and Act 72 (SLH2016) provided \$1,450,000 in general funds for KIRC operations for FY2017. In May 2017, the KIRC Commission approved a FY 2017 Budget that aligns its fundraising and spending plans. (See attached memo: “Budget for FY2017 for Approval”). In June 2017 the KIRC Commission approved a FY 2018 Budget that that aligns its fundraising and spending plans. (See attached memo: “Proposed Budget for FY2018”).

Also included in Act 49 (SLH2017) was initial Capital Improvement Project (CIP) funding to begin the design of the KIRC’s Kaho‘olawe Education & Operations Center at Kīhei, Maui. The KIRC is currently working with a contractor to complete the initial designs and entitlements necessary to bring the project to construction ready status prior to seeking additional funding.
