HB1600 Relating to the State Budget

Purpose: Adjusts and requests appropriations for fiscal biennium 2021-2023 funding requirements for operations and capital improvement projects of Executive Branch agencies and programs.

Restores KIRC funding (\$100,000) established in Act 49, SLH 2017, add new KIRC Cultural Specialist II position

HD1: Increase KIRC request from \$100K to \$500K
Increase KIRC request from 1.0 FTE for Cultural Program to 2.0 FTE

SD1: Decrease KIRC request back to \$100K
Fulltime funding for 2.0 FTE
Adds \$500K CIP funding for on-island improvements

SD2: No changes affecting KIRC

CD1: Add non-reoccurring increase in General Funds for FY23: \$400K
Add two permanent positions (six-month funding for FY23)
Add \$500K in CIP funding for base camp improvements

SB2067 Relating to Burial Sites (Measure dead)

Purpose: Establishes an inter-division program between the State Historic Preservation Division, county burial councils, Office of Conservation and Coastal Lands, and the Office of Hawaiian Affairs that addresses the location, movement, and restoration of Hawaiian burial sites, or ‘iwi, exposed or likely to be exposed to coastal erosion.

SD1: Adds Land Division to program, clarify scope and to define policy
